

Lokanayak Omeo Kumar Das College Student Union Election, 2024-25.

THE IMPORTANT GUIDE LINES ISSUED BY HON'BLE SUPREME COURT ON 22-09-2006 ON STUDENT UNION ELECTION

1. The union/ representative body so selected shall only comprise of regular students on the rolls of the institution (On 6.1.8)
2. The candidate must be a regular, full time student of the college and shall not be a distance education student. (On 6.5.8)
3. The contesting candidates of the college should not be more than 22yrs of age and less than 17 yrs. (On 6.5.1)
4. The candidates should not have any Academic arrear in the contesting year (On 6.5.4)
5. The candidates shall have one opportunity to contest for the post of office bearer and two opportunities to contest for the post of an Executive Member. (On 6.5.6)
6. The candidates shall not have a previous criminal record. (On 6.5.7)
7. No candidate shall be permitted to make use of printed posters, printed pamphlets or any other material for the purpose of canvassing. Candidates may only utilize hand-made posters. (On 6.7.5)
8. The maximum permitted expenditure per candidate shall be Rs. 5000/- only. (On 6.6.1)
9. The candidates shall within two weeks of the declaration of the result should have to submit the accounts on expenditure (to be certified by the candidate) to the college authority (On 6.6.2)
10. The candidate could not serve or distribute any eatable or other solid and liquid consumables, except water on polling day (On 6.7.11)
11. No candidate shall indulge in any activity which may create mutual hatred or cause tension between different casts and communities, religious and linguistic or between any group (s) of students. (On 6.7.1)
12. There shall be no appeal to caste or communal feelings for securing votes. (On 6.7.3)
13. No candidate shall be permitted to carry out processions or public meetings out side the college campus. (On 6.7.7)
14. The use of loud speakers, vehicle and animals for the purpose of canvassing is prohibited. (On 6.7.10)
15. Any instance of acute lawlessness or the commission of a criminal offence shall be reported to the police by the college authority. (On 6.9.1)
16. During the period of election no person, who is not a student on the rolls of the college shall be permitted to take part in the election process in any capacity. Any person, candidate or member of the student organization violating this rule shall be subject to disciplinary proceedings, in addition to the candidature, as the case may being revoked. (On 6.3.1)





Lokanayak Omeo Kumar Das College Student Union Election, 2024-25
BRIEF GUIDE LINES AS PER CONVENTION
AND CONSTITUTION OF THE COLLEGE

1. Only bonafide students having 75% attendance in the class of Lokanayak Omeo Kumar Das College are eligible to be a candidature, proposer and seconder in the election.
2. The proposer or seconder of a candidate must not propose or second other candidates.
3. The candidate, proposer, seconder should write their name as per college register/ identity card.
4. The candidate, proposer, seconder and voters must bring their admission money receipt and identity card at the time of scrutiny and at the time of voting.
5. The President must be from Degree class but only from 2nd Year i.e. 3rd Sem.
6. The General Secretary must be from Degree class but not from 3rd year i.e. 5th and 6th semester class. Rest secretaries must be also from either 1st Sem. or 3rd Sem.
7. A candidate along with only two persons will be allowed to attend in scrutiny works and thus in case of counting of ballot papers.
8. The candidate, proposer and seconder should have to be present during scrutiny of nomination papers and should furnish relevant documents required by the scrutiny board.
9. A candidate can place one polling agent in one polling center, however he or she can be replace by other.
10. The polling agents should have to declare his or her opinion at the end of polling in written form about the conduct of the election.
11. Without uniform no one is allowed to caste his / her vote. At the time of voting they must bring their money receipt and identity card.
12. In all matters of dispute the decision of the election commission will be final.
13. In addition to supreme Court Rules and Regulations and Lokanayak Omeo Kumar Das College convention & constitution, the candidates are hereby directed to follow the time to time notification related to nomination, scrutinisation, voting and counting of student union election.
14. Any candidate violating the guidelines of student union election furnishing false statement/document shall be subject to disciplinary actions in addition to the cancellation of candidature, as the case may be revoked.
